

## Book Review: A Global Perspective on Victims of Crime and Victim Assistance: Best Practices around the World

The book, "A Global Perspective on Victims of Crime and Victim Assistance: Best Practices around the World is an important scholarly contribution that has been published at a critical time when the discipline of victimology is going through a transition. The role of victim assistance is highlighted through crime prevention and proactive policing suggesting useful tools that can be adopted to protect Individuals, communities and institutions.
